*The Corporation will not be responsible for any damage or theft of the vehicle or any property taken from the vehicle;*

*Will respect the following guidelines:*

### GUIDELINES

- Lock 7 has been identified as the Parking Area for sailors and pilots.
- An Access Waiver must be signed and a Parking Pass obtained prior to parking in the Lock 7 Parking Area.
- The Parking Pass must be presented to the Lock crew to gain access to the Lock 7 Parking Area.
- The Parking Pass must be displayed on the dash of the vehicle while it is parked in the Lock 7 Parking Area.
- Vehicles must be parked 75 ft. from the lock wall.
- The Access Waiver and Parking Pass are in effect for one navigation season only.
- Under normal circumstances, security Marsec Level 1 is in effect at the locks. However, if circumstances change and security Marsec Levels II or III are in effect, there may be some restrictions in accessing the Lock 7 Parking Area.
- This permission can be revoked at any time without prior notice.
